Chairman/Vice-Chairman and members (Category wise detail)</p>	<p>The Goa State Agricultural Marketing Board.</p> <p>The Board Consists of the following 17 Members namely:-</p> <p>A) Ten Agriculture including two lady agriculturists only.</p> <p>B) One trader holding A Class License to be elected from amongst Trader of all classes</p> <p>C) Two Trader Co-operative Societies registered in the State of Goa and which have paid highest amount of fees in preceding market year to the Marketing Board, shall be represented by their respective Chairman to function as Ex-officio members of the marketing Board during the term of the elected marketing Board.</p> <p>D) One Chairman of a Co-operative Society registered in the State of Goa doing the business of processing of marketing of agricultural produce of notified commodities in the market area to be elected from amongst the Chairman of such Co-operative Societies.</p> <p>E) Two members to be nominated by the Government, one being from the office of the Registrar of Co-operative Societies, Government of Goa, and the other being from the Department of Agriculture, Government of Goa, to function during the term of the elected Marketing Board.</p>
